## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby sets forth and declares:

### Article I

The name of the Corporation shall be Clean Shower Motor Sports, Inc.

### Article II

The Corporation may engage in any lawful activity or business for which corporations may be organized under the Florida Business Corporation Act.

### Article III

The aggregate number of shares which the Corporation shall have authority to issue shall be 1,000 shares of Common Stock, \$.01 par value per share, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine. The shares of the Corporation shall not be divided into classes, and the Corporation is not authorized to issue shares in series.

### Article IV

The street address of the Corporation's initial principal office shall be 11232-1 St. John's Industrial Parkway, Jacksonville, Florida 32246. The Corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the Board of Directors of the Corporation may, by resolution, designate.

#### Article V

#### Article VI

The Corporation shall have a Board of Directors of not less than one (1) director, which number may be increased or decreased to a number not less than one in a manner specified in the Bylaws of the Corporation.

#### Article VII

The street address of the initial registered office of this Corporation is 1200 South Pine Island Road, Plantation, Florida 33324, and the name of the initial registered agent of this Corporation at that address is CT Corporation System.

#### Article VIII

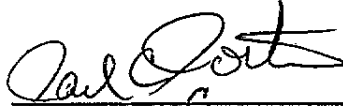
The initial Bylaws of this Corporation shall be adopted by the Board of Directors. The directors may make, amend or repeal the Bylaws in whole or in part, except with respect to any provision of the Bylaws that by law or by these Articles, requires action by the shareholders.

#### Article IX

Any shareholder present at any meeting, either in person, or by proxy, and any director present in person at any meeting of the Board of Directors shall conclusively be deemed to have received proper notice of such meeting unless he or

she shall make objection at the beginning of such meeting to any defect or insufficiency of notice.
