The undersigned incorporator, J & M SALES & ENGINEERING, INC., an entity authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is E.F. SUB., INC.

ARTICLE II - PRINCIPAL OFFICE

The initial address of the principal office of the corporation is P.O. Box 449, Pensacola, FL 32592.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue ten thousand (10,000) shares of \$1.00 par value common stock.
