The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is KALESI CORPORATION.

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under laws of the United States and of the State of Florida.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of the corporation is 3199 NW 20 St. Miami, Florida 33142, and the mailing address is the same.

ARTICLE 4 - INCORPORATORS


#### ARTICLE 11- EFFECTIVE DATE
