The undersigned, acting as incorporators, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be APTIC National Tax Service Company.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 493 East Semoran Boulevard, Casselberry, Florida 32707.

ARTICLE III - TERM OF EXISTENCE
