The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. - CORPORATE NAME

The name of the Corporation is IVANHO FOOD ENTERPRISE OF INTERNATIONAL MALL 2 INC.

#### ARTICLE II. - CORPORATE DURATION
