ARTICLE I - NAME

The name of this Corporation is Double J Nursery, Inc. and the address is 19848 E. Altoona Road, Altoona, Florida 32702.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall begin on January 14, 1998, and shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
