

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: COMPLETE INTERIORS OF TAMPA BAY, INC. The address of the principal office of this corporation shall be 5216 Carrollwood Meadows Drive, Tampa, Florida 33625, and the mailing address of the corporation shall be P.O. Box 8932, Tampa, Florida 33674-8932.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV -- REGISTERED AGENT

The street address of the initial registered office of the corporation shall be 5216 Carrollwood Meadows Drive, Tampa, FL 33625, and the name of the initial registered agent of the corporation at that address is Harry A. Pinero.

ARTICLE V - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI - DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. This corporation shall have one Director, initially. The name and address of the initial member of the Board of Directors is:
