### ARTICLES OF INCORPORATION OF ROAD TO RECOVERY, INC.

SECRETARY PH 4:35 The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

#### ARTICLE I. Name

The name of this Corporation shall be ROAD TO RECOVERY, INC.

#### ARTICLE II. Address

The principal place of business, and the mailing address, of this Corporation shall be 2589 Pine Ridge Road, Tallahassee, Florida 32308.

#### ARTICLE III. Corporate Purposes

The Corporation is organized for the purpose of engaging in any or all activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE IV. <u>Term of Corporate Existence</u>

This Corporation shall have perpetual existence unless dissolved according to law.

## ARTICLE V. Corporate Powers

This Corporation shall have and exercise all the powers accorded corporations under the laws of the State of Florida.

#### ARTICLE VI. Stock
