The Undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be C.U. Productions, Inc., and it shall hereinafter be referred to as "Corporation".

ARTICLE II

The principal place of business of this Corporation shall be 149 White Street, Daytona Beach, FL 32114, and the initial mailing address of this Corporation shall be P.O. Box 265781, Daytona Beach, FL 32126-5781.

The existence of this Corporation shall be perpetual.

The name and street address of the Incorporator of these Articles of Incorporation is: Toni Diamond, 149 White Street, Daytona Beach, FL 32114.


