ARTICLE ONE

The name of the corporation is **Global Electronics Consulting, Inc.** The principal address of the corporation is: 3505 W. Atlantic Blvd. #914, Pompano Beach, Florida 33069.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.


ARTICLE EIGHT
