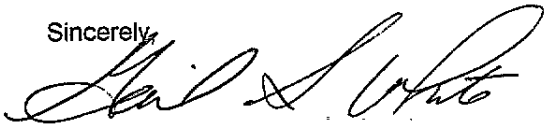

of TAILORED PC DOCUMENTS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of this Florida corporation shall be Tailored PC Documents, Inc.

**ARTICLE IX INDEMNIFICATION**

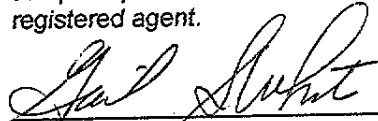
The Corporation will indemnify any director or officer, or any former director or officer, to the fullest extent permitted by law.

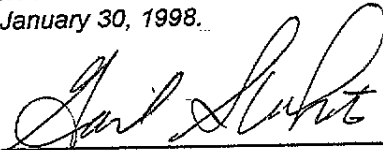
