ARTICLES OF INCORPORATION
OF
A PIECE OF CAKE OF SARASOTA, INC

SECKLTAR I OF STATE TALLAHASSEE, FLORIDA

ARTICLE I

Name. The name of this corporation is A PIECE OF CAKE OF SARASOTA, INC.

ARTICLE II

<u>Duration</u>. The corporation shall be perpetual.

ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

<u>Capital Stock</u>. This corporation is authorized to issue 1,000 shares of common stock at \$1.00 par value, which shall be designated "Common Shares".
