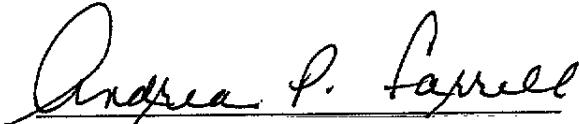

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION, COMPETENT TO CONTRACT, HEREBY FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE ONE- CORPORATE NAME

THE NAME OF THE CORPORATION IS:

KALI ENTERPRISES, INC

ARTICLE TWO- DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY UNLESS DISSOLVED UNDER FLORIDA LAW.

ARTICLE THREE- PURPOSE

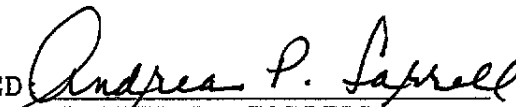
