ARTICLE I- NAME

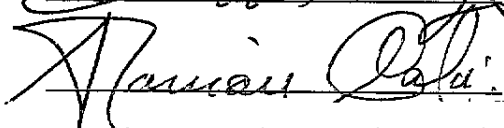

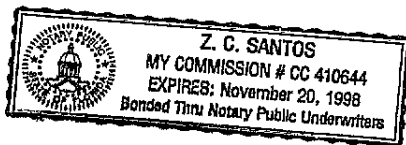
