ARTICLES OF INCORPORATION

OF

ISC/U.S. INC.

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be ISC/U.S. Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on February 1, 1998 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

dividends due them for any indebtedness of the shareholders to the corporation.

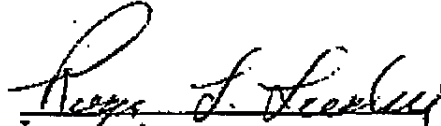
ARTICLE IX - AMENDMENTS TO ARTICLES
