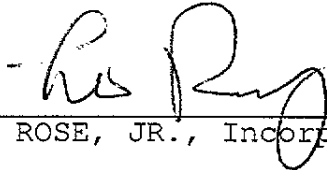
This corporation shall initially have one (1) director(s). The number of directors may be increased or decreased from time to

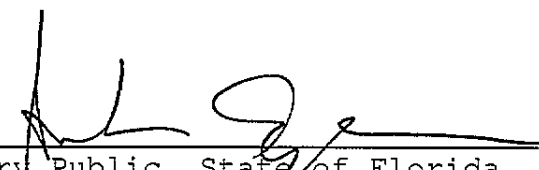

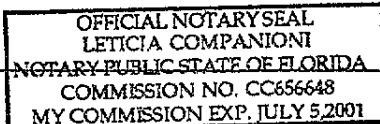

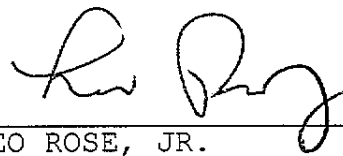
