The undersigned hereby forms a corporation for profit under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

The address of the principal office of this corporation shall be 820 Simonton Street, Key West, Florida 33040, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

It is the intent of the incorporator that the corporation will qualify under Section 1244 of the Internal Revenue Code.

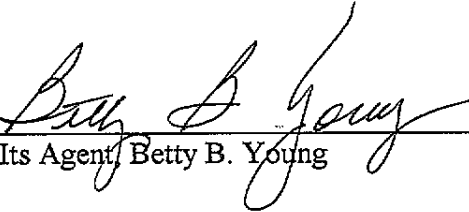

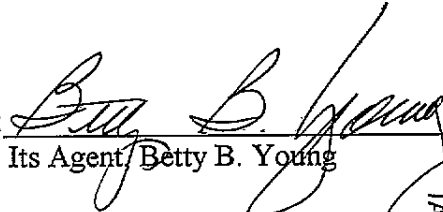
