ARTICLES OF CORRECTION  
FOR WOERNER HOLDINGS, INC.,  
A FLORIDA CORPORATION (THE "CORPORATION")

Pursuant to §607.0124 of the Florida Statutes, as amended, the undersigned hereby submits the following information:


1. On February 27, 1998, Articles of Merger for **WOERNER HOLDINGS, INC.** were filed with the Florida Secretary of State (the "Florida Articles").
2. The Florida Articles identified an effective date of the merger on March 1, 1998 and the effective time of 12:01 a.m. In order to effectuate the merger, it was necessary to file Articles of Merger with the Secretary of State of Alabama (the "Alabama Articles"). The Corporation failed to file the Alabama Articles with the Secretary of State of Alabama until March 2, 1998. Accordingly, the merger is not effective until March 2, 1998.
3. Paragraph 4 of the Florida Articles referenced in Paragraph 1 above is hereby deleted in its entirety and shall read as follows:

"4. The effective date of this merger shall be March 2, 1998."
