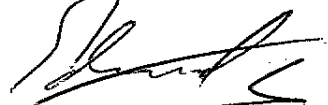

The undersigned, for the purpose of forming a corporation pursuant to the laws of the State of Florida, hereby adopts the following:

ARTICLE I

NAME

The name of the corporation is **NELSON A. MALDONADO, M.D., P.A.**, and the address of it's principal place of business is **501 GOODLETTE ROAD NORTH, BUILDING A-100, NAPLES, FL 34102.**

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation by the Department of State.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business, with the principal purpose being rendering health and medical services to the public.

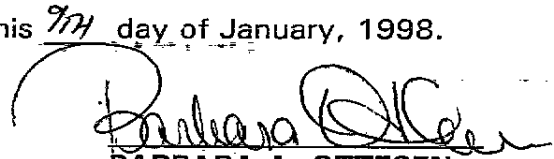
