Article I

Name

The name of the corporation is DC INTERIORS, INC.

Duration

The corporation shall have perpetual existence.

Article III

Purpose

Article V

Capital Stock

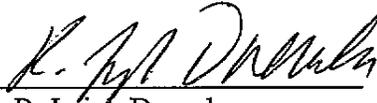
