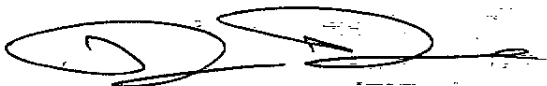

Articles of Incorporation

I. Name

The name of the Corporation is The Inspection Team Inc., hereinafter referred to as the "Corporation."

II. Purposes

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

III. Principal Office and Registered Agent

The principal office of the Corporation is 5730 NW 62 Manor, Parkland, Florida 33067. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. The name and address of the registered agent for service of process upon the Corporation is David Dunne, 5730 NW 62 Manor, Parkland, Florida 33067.

IV. Duration

The duration of the Corporation shall be perpetual.

V. Initial Business

The initial business of the Corporation shall be: Inspection of property and buildings for clients without prejudice or malice.

VI. Capital Stock

The Corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock. The total number of shares the Corporation shall have authority to issue is 90, each share to have a par value of \$1.00.

The private property of the stockholders and or the incorporators shall not be subject to the payment of corporate debts.

Operating Provisions

The provisions for the operation, regulations, and management of the business and internal affairs of the Corporation shall be as set forth in the Bylaws, which may be amended from time to time by a majority vote of a quorum of the Board of Directors.

The number of directors constituting the initial Board of Directors of the Corporation is: three. The names and addresses of the persons who are appointed to act as the initial director of the Corporation are:

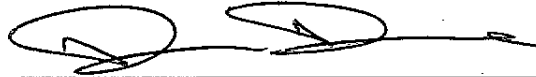

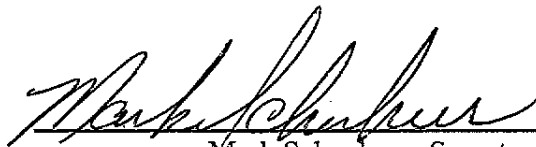

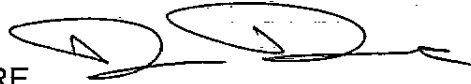
