In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is AUTOMOBILE INVESTIGATIONS, INC.

ARTICLE II

The existence of the corporation shall begin on the date of filing of these Articles of Incorporation.

ARTICLE III

The street address of the principal office of the Corporation is 6165 South Mirror Lake Drive, #110, Sebastian, Florida 32958.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000 with a par value of \$1.00 per share, all of which shall be Common Shares. 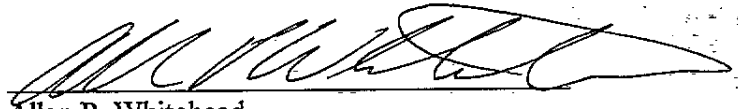
