The undersigned acting as incorporators of a corporation under the Florida Administrative Code, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Auto Detail Consultants, Inc.

SECOND: The period of its duration is indefinite.

THIRD: The purpose or purposes for which the corporation is organized are: for the transaction of any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50 shares at a par value of \$10.00 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: None.

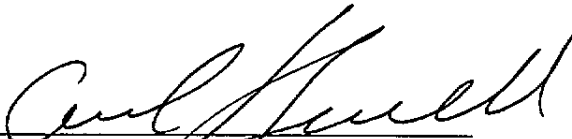
