Article I Name

The name of the Corporation is <u>D.C.M</u>, <u>Contracting</u>, <u>Inc.</u>

Article II Duration

The Corporation shall commence its existence on <u>January 31, 1998</u> and shall have perpetual existence.

Article II Purpose

The nature of the business to be promoted and carried on, is to engage in any lawful activity for which Corporations may be organized under the General Corporation laws of the State of Florida. The Corporation is organized for the purpose of transacting business relating to, but not necessarily limited to, repairs, installation, construction, or remolding and consulting.
