**ARTICLE I - NAME**

The name of this professional service corporation shall be Dixon, Lefler & Lorenzen, P.A..

**ARTICLE II - DURATION**

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

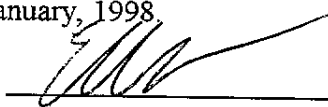
