ARTICLES OF INCORPORATION

OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be:

and shall perform all business under the name of:

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. SHARES

This corporation is authorized to issue 100000 shares of common stock with a par value of \$.01 , which shall be designated "common shares".

ARTICLE IV. PURPOSE

This corporation shall commence JANUARY 25, 1998 and shall have perpetual existence.

ARTICLE VI. PREEMPTIVE RIGHTS

The personal liability of any of the shareholders, and/or the officers, of the above corporation is limited to their respective percentage of stock ownership as compared to all of the issued stock.

ARTICLE VIII. INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE IX. INITIAL BOARD OF DIRECTORS

This corporation shall have 1 directors initially.
The number of directors may be either increased or diminished
from time to time by the bylaws but shall never be less than
