ARTICLES OF INCORPORATION OF Always Right Roof Services, Inc.

The undersigned subscriber to these Articles of Companies of Companies

ARTICLE I NAME

The name of the corporation shall be Always Right Roof Services, Inc.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of FLORIDA, or any other state, county, territory or nation.
