**ARTICLE I - NAME**

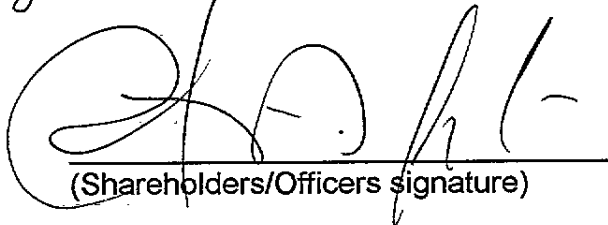
### **ARTICLE X - AMENDMENTS**
