ARTICLES OF INCORPORATION  
OF

TOM'S CUSTOM CONCRETE AND TRACTOR WORK, INC.

The undersigned subscriber, a natural person competent to contract, and where duly licensed to render the services mentioned in Article II - Purpose, hereby organize and incorporate a business for profit under the laws of the State of Florida.

ARTICLE I - Name

The name of the corporation shall be: TOM'S CUSTOM CONCRETE AND TRACTOR WORK, INC.

ARTICLE II - Address

The principal office of the corporation shall be located at 12563 Brady Road, Jacksonville, Florida 32223; the mailing address is the same address.
