Please accept this letter in response to your letter dated May 18, 2000 and another letter dated May 16, 2000 for the above referenced companies.

I have had to assume the management of the above companies because my partner, Raul Armengol, had a severe stroke. When he had this stroke last year, I obtained all of the paperwork regarding the companies from his wife. At that time, I filed the annual report for Air Conditioned Self Storage of Marathon, L.P. Unfortunately, Mrs. Armengol did not have or did not hand over the annual report for Air Conditioned Self Storage of Marathon, Inc. to me. (I was also unaware that two separate reports needed to be filed for the same venture) Therefore, an annual report for this company was not filed in 1999. I am now trying to correct this situation.
