ARTICLE I - NAME

The name of the Corporation is Shades of Wetappo, Inc.

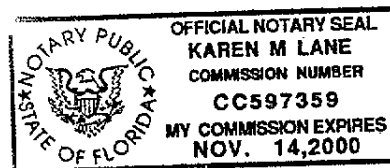


