ARTICLES OF INCORPORATION
OF

ARTICLE I

NAME AND ADDRESS

The name of the corporation is LIBERTY CONTAINER LINE, INC.

ARTICLE II

DURATION

This corporation shall have a perpetual existence commencing
upon filing of the Articles of Incorporation with the Secretary of
State.

ARTICLE III

PURPOSE


