

**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of DOUGLAS J. COX, INC. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

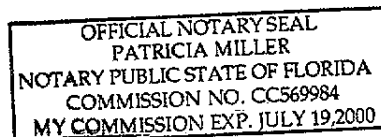
