#### Article I

The name of this Corporation is RPI-II, INC. Name. EFFEUTIVE DAIL

## Article II

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

### Article III

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including, but not limiting the acquisition of life debentures, commodities, insurance leaseholds, bonds, options, puts and calls, easements, mortgages, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

## Article IV

Capital Stock. This Corporation is authorized to issue 1000 shares of One Cent (\$.01) par value common stock.

#### <u>Article V</u>

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.
