I, the undersigned, hereby subscribe to, acknowledge and tile the following Articles of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

<u> ARTICLE I - NAME</u>

The name of this corporation is: VENTOTENE, INC., a Florida corporation.
