The following Articles of Incorporation are adopted by the undersigned, for the purpose of forming a corporation under the provisions of the laws and statutes of the State of Florida:

# ARTICLE I

(NAME)

The name of the corporation is:

BELL CREEK EQUESTRIAN CENTER, INC.

# ARTICLE II

# (INITIAL PRINCIPAL OFFICE)

The initial principal office and mailing address of the corporation is 3816 South Nine Drive, Valrico, Florida 33594.

# ARTICLE III

(DURATION)

This corporation shall have a perpetual existence.

# ARTICLE IV

(PURPOSE)

The purposes for which this corporation is organized are:

To transact any and all other lawful business in which corporations may engage under the laws of the State of Florida.

### ARTICLE V

# (CAPITAL STOCK)

The corporation is authorized to issue 10,000 shares of stock having a par value of \$.10 per share. All shares of stock shall be designated as common shares. The stock may be issued in fractioned shares and may be canceled and reissued at any time in whole or in part in compliance with the By-laws of the Corporation. Dividends may be payable either in cash, property, or shares of the common stock of the corporation, as determined by the Corporation's Board of Directors.
