Dear Ms. Baumann,

An on-going project of the City of Delray Beach is to make sure that addresses of properties in the city are "correct". By this I mean, that they are numbered in a logical order according to the city's numbering grid and other properties in the area. This is very important for response by emergency personnel - police, fire, rescue squad. The post office and other services such as garbage pickup, FPL, etc. also require a logical ordering of addresses.

The current address of your property was assigned when you were in Palm Beach County only, before being annexed into the City of Delray Beach.

The changing of your address involves changing the number on your store (which the landlord is doing - but also keeping the old address until March 1.) You will have to notify any utility providers such as FP&L, Southern Bell, Cable TV, but this can be done when you pay your bills. The city will notify the responsible parties regarding water/sewer, garbage, 911 and post office. We will issue you a City Occupational License with the new address at no charge.

I realize that this is an inconvenience, but your address must be changed as noted below. Since you may have stationary, brochures, or other items with the old address I am asking that you change your address **no later than March 1, 2006**. You may change it sooner if you so desire. I have included a copy of this letter and my business card. Please sign and return the copy when you have taken all steps and the new address can be the only address. On February 1, 2006, I will contact anyone that I have not heard from, so the change can be accomplished by March 1.

I will assist you in any way that I can. Thank you for your cooperation.
