**ARTICLE ONE

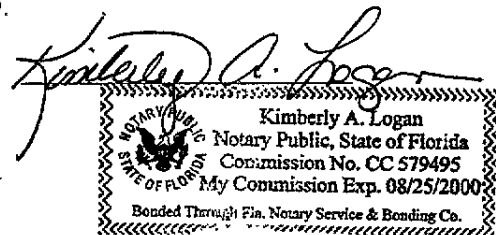
