**ARTICLE I - NAME**

The name of the corporation is Smart Marketing Solutions, Inc. (hereinafter called the "Corporation").

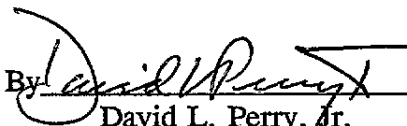
