

## ARTICLES OF AMENDMENT

Pursuant to the provisions of Section 607.187, Florida Statutes, the undersigned corporation, as executed by its President and Secretary and acknowledged by its Secretary, hereby executes these Articles of Amendment as follows:

A. The name of the corporation is MICHAEL D. CHESEN, O.D., & P.A.

B. The Amendment as duly adopted is as follows:

Notwithstanding anything to the contrary contained in these Articles of Incorporation, the Florida Statutes or the Corporation's Bylaws, the Corporation shall not engage in any business activity other than that which is directly related to the operation of the Pearle Vision or such other Pearle Vision, Inc.
