#### ARTICLE I - NAME

SECRETARY OF STATE

The Name of the corporation is NetStore, USA, Inc.

## ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing on the date of filing of these articles, unless sooner dissolved according to law.
