The duration of the corporation shall be perpetual.

III

The purpose for which the corporation is organized is to develop real property. The business may engage in any activity or business as permitted under the laws of the United States and under the laws of the State of Florida.

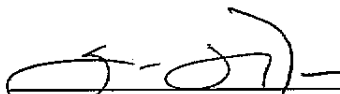
