

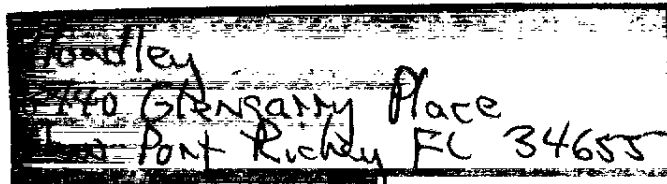

ARTICLES OF INCORPORATION

ARTICLE 1: NAME AND ADDRESS

The name of this Corporation is : HOADLEY CONSULTING SERVICES, INC. and the address is: 8440 Glengarry Place, New Port Richey, FL 34655.

ARTICLE 2: DURATION

This Corporation shall exist perpetually. In accordance with Section 607.0203, the date when existence shall commence is the date of subscription and acknowledgement of these Articles of Incorporation.

ARTICLE 3: PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.


ARTICLE 10: INDEMNIFICATION

ARTICLE 11: POWERS OF INCORPORATORS

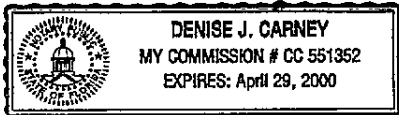
The powers of the incorporators cease upon filing of the Articles of Incorporation.
