SIXTH

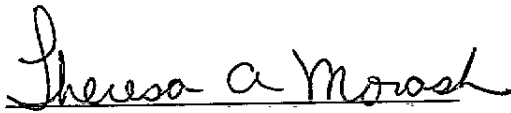
