I, the undersigned, hereby execute the following document for the purpose of ASSEE, Florence and Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of Corporation For Profit.
