

ARTICLE I.

NAME

The name of the corporation shall be: Advantage Cleaning Supply, Inc.

ARTICLE II.

DURATION

The duration of the corporation shall be perpetual and its existence shall commence upon filing of these Articles with the Florida Department of State.

ARTICLE III.

PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.


