ARTICLES OF INCORPORATION OF YOGI DIVINE SOCIETY OF ORLANDO, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE_I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is YOGI DIVINE SOCIETY OF ORLANDO, INC. The principal place of business of the Corporation is 201 PARK PLACE SUITE #207 ALTAMONTE SPRINGS, FLORIDA 32701. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 201 PARK PLACE SUITE #207 in the city of ALTAMONTE SPRINGS in the County of SEMINOLE. The name of the registered agent at such address is DINESH CHOKSHI.

ARTICLE III

CORPORATE PURPOSE, POWERS AND RIGHTS

- 1. The purposes of the Corporation shall be,
 - (a) To establish, construct and operate traditional style Religious Centers for the purpose of providing a place of worship and prayer for people believing in Lord Swaminarayan, and Hindu philosophical teachings.
 - (b) To promote religious, spirtual, cultural, civic, educational and social activities amongst people who believe in Lord Swaminarayan, and Hindu philosophy.
 - (c) To support humanitarian causes.
 - (d) To make distributions to organizations under Section 501(e) of the Internal Revenue Code (or the corresponding section of any future Federal Tax Code).

INCORPORATOR

The power of the incorporator shall terminate upon the filling of the Articles of Incorporation of the Corporation with the office of the Secretary of State of Florida.

ARTICLE V

BOARD OF MEMBERS & TRUSTEES

The Corporate Members shall be individuals, over the age of eighteen (18) years and may be a resident of any of the states of the United States or citizens of any soverign state. In general, the member shall be an individual with faith and interest in Lord Swaminarayan, Hindu religion, culture and philosophy and with an interest in the activities of the Corporation. Each corporate member (general member) shall be approved by at least one trustee. Honorary membership shall be conferred only upon the approval of a majority of trustees.

The acitivities of the Corporation shall be managed by the Board of Trustees, which shall consist of Seven (7) trustees (the "Board"). Powers and duties, Election and term of office, Vacancies and removal, Meetings and management of board of trustees are as per the by-laws of the Corporation.
