AMENDMENT

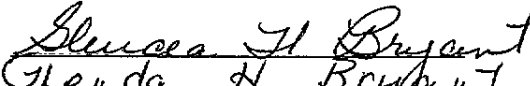

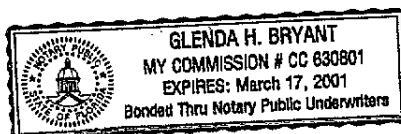

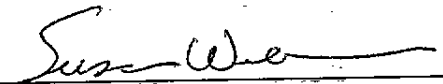
