ARTICLE OF INCORPORATION

OF

ALPHA PROFESSIONALS, INC.

ARTICLE ONE

The name of the corporation is ALPHA PROFESSIONALS, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is FOUR HUNDRED FIFTY (450) shares of common stock of no par value.

ARTICLE FIVE
