THE UNDERSIGNED, acting as (an) incorporator(s) of a corporation, adopt(s) the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is Callisto Consulting Company.
- 2. The period of duration of the corporation is perpetual.
- 3. The purpose or purposes for which the corporation is organized are to engage in any lawful purpose or purposes and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the state of Florida.
